AUCTION NOTICE

It is to informed to all concerned that Tinsukia Municipal Board, Tinsukia has proposed to dispose the condemned iron scraps/vehicles through Govt. authorized "Registered vehicle Scrapping facility Centre."

Accordingly, sealed bids/quotations affixing court fee stamp of Rs. 8.25 (Rupees Eight and twenty five paisa) only are invited for disposal of the iron scrapes. The bids/quotations addressed to the undersigned in a sealed cover super scribed in capital letter with "OFFER FOR AUCTION SALE OF IRON SCRAPES" along with earnest money (refundable) Rs. 2000.00/- (Rupees Two Thousand) only in the shape of Bank Draft in favour of Chairman/Executive Officer, Tinsukia Municipal Board, Tinsukia should be deposited latest by 14.00 hrs on 24.07.2025. A Tender Box will be kept for this purpose in office of the Tinsukia Municipal Board office, Tinsukia from 11.00 A.M. to 2.00 P.M. The Bids/quotations received will be opened by the (Tender Evaluation Committee) on 29.07.2025 at 15.00 hrs in the conference hall of Tinsukia Municipal Board, Tinsukia. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotations. Before quoting bid, the iron scraps may be inspected at Dak Banglow premises located at Thana Charali Point Tinsukia during the office hours on or before the last date closure of tender.

The Auction will be governed by the following terms and condition:-

- 1. The Base price of the iron Scrapes are Rs. 25000.00/M.T.
- 2. Each Scrape will be sold to the highest bidder. However, the undersigned reserves right to accept or reject any tender without assigning any reason thereof.
- 3. Quotation received without bank Draft towards Earnest Money will not be accepted
- 4. The bidder belonging to Schedule castes, Schedule tribes or other backward classes will be required to deposit only 50% i,e 1000.00 as earnest money (E.M.D.) Those who claim to belong to any of these categories must have submit Caste Certificate from competent authority to establish the same.
- 5. The successful bidder will be required to deposit the complete bid amount by means of bank Draft drawn in favour of Chairman/Executive officer, Tinsukia Municipal Board, Tinsukia within 7 (Seven) working days of acceptance of the bid. Failing to do so will lead the bidder to forfeit the Earnest money (EMD) to the State Ex-chequer and the iron scraps will be sold to the next highest bidders.

- 6. The earnest money deposited before start of auction shall return to the unsuccessful
- 7. Withdrawal of Bid once submitted is not permitted under any circumstances.
- 8. The Earnest money of the successful bidder will be released after 6 (six) months. 9. The successful bidders will have to remove the iron scrape from the respective premises at their own cost by the parties concerned.
